

Website Terms of Use

(For Sending Wishes).

Welcome to www.convertor.ge. This document sets out conditions for website Terms of Use and applies to persons as well as to legal entities. The document also defines "Convertor.ge" Ltd (ID#: 402008527) rights and responsibilities, as it owns and administers the website www.convertor.ge. Please read this document below and consider each section, because by visiting the website, by sending wishes, by filling out the application, by registering, or by using any service it is considered that you automatically agree to the conditions defined in the Terms of Use of the website.

1. Introductory Provisions

1.1. Through www.convertor.ge- (hereinafter the "Website") the website visitors (Hereinafter referred to as "Users") can send their wishes for the purpose of purchasing different kinds of property and get the respective offers.

1.2. The User can be any person, or a legal entity.

1.3. Sending wishes is free of charge and is unlimited.

1.4. In order to send wishes, the User must write it on a "Wish Board," that is on the Website, indicate an E-mail address or phone number or personal Facebook profile link and agree to the "Website Terms of Use."

1.5. The wishes sent by Users should be related to the business activity indicated in section 1.1.

1.6. The Users receive offers relevant to their wishes from real estate owners, brokerage companies, or individuals (hereinafter the "Supplier").

2. The User's Data Usage and Protection

2.1. "Convertor.ge" Ltd (hereinafter the "Company") has the right to receive the wishes sent by Users on www.convertor.ge, for further study and response purposes.

2.2. The company has the right to not only receive a wish, but also add User's E-mail, or Phone number or Facebook profile link to its database.

2.3. The Company has the right to send the User's wish text and/or E-mail, Phone number, Facebook profile link to the suppliers for the purpose of sending offers to them.

2.4. The Company has the right not to send the User's information and data to the supplier if it does not comply with the purpose referred to in section 1.1.

3. Supply of Users' Information and Accuracy

3.1. The Company is not responsible for the information accuracy, quality, speed, and quantity supplied by Suppliers to Users.

3.2. In case the User does not want to receive further information and offers, he/she should apply directly to the Supplier.

3.3. The Company has the right to send Website Evaluation Form to Users through E-mails, or Facebook profile link or connect on the mobile indicated during sending wish.

3.4. The Company has the right to send news about the Company to Users through the E-mail, Facebook profile link or Phone number indicated when sending a wish.

4. Rules of User's Behavior

4.1. Users must comply with the conditions laid down in the present document.

4.2. Users shall not carry out any actions mentioned below:

4.2.1. To attempt to enter website protected section that the User is not allowed to do.

4.2.2. To use any automatic or manual operation to access, or search any information, in order to interfere the website proper functioning process.

4.2.3. To use any kind of virus program ("worm", "trojan horse", "virus", "spyware", "carding"), which would jeopardize the functioning of the website and jeopardize the website usage safety for Users;

4.2.4. Usage of obscene language when sending wishes, or insulting the Company, or a third party.

4.2.5. To use the website for the purpose of creating unwanted spam.

4.2.6. To attempt or carry out threatening activity against proper functioning of the platform, in the purpose of revealing the source code, on which the website functioning is based on.

4.2.7. To indicate other individual's E-mail, Phone number or Facebook link, when sending a wish.

5. Liability of the Company

5.1. The Company does not endorse any of the Suppliers and is not their representative.

5.2. The Company's scope of work is to process the User's wish and send it to the relevant Supplier.

5.3. The Company does not take the responsibility that the User's wish will be definitely satisfied.

5.4. The Company may terminate, or limit User's access to the website, or service usage, without any prior agreement. At the same time, the Company does not take responsibility for the harm or loss that User may have from such kind of action.

5.5. The Company itself does not take responsibility if the User's, or any other third party's computer (or any of its part), or a mobile device will be damaged while using the website, or link on the website for getting information, or downloading of any program from the website.

5.6. The Company is exempt from responsibilities, such as: telephone networks, computer systems, servers or providers, computer or telephone equipment's software services, e-mail services technical problems, or other technical flaws; assumptions, errors; interruptions and delays during data processing and transmission; defects; Users' data theft, destruction, or unauthorized access.
